




PROPERTY SUMMARY

The single story building features a full bar set up, newly equipped 20-ft. commercial kitchen hood system, spacious dining areas, 2 divided party rooms, 3 walk-in coolers/freezers, sound room/office, high-top area, and outdoor patio. The property has 46 parking spaces and good visibility. The site has ample parking, superb visibility, and exposure, with approximately 102.5 feet of frontage along Cervantes St. (13,500 VPD). Located in a highly sought-after area, the site is within minutes of Downtown Pensacola, Scenic Highway Neighborhoods, and local schools. Nearby major retailers include Publix and CVS Pharmacy.








15 MINUTE DRIVETIME MAP
